

Summary

Maintenance works this month have included grading, metalling, culvert end clearing, edge marker post replacements, line marking and pre reseal pavement repairs.

This month we have also completed our reseal program, with 21.9km of sites completed following pre reseal repairs.

April has been busy ramping into storm damage repairs with good progress made on Diggers Valley Rd, Runaruna Rd, Matawherohia Rd, Taupo Bay Rd and Paponga Rd. Weather dependent, storm damage repairs will be a large focus over the coming months.

Works Programme

A total of 798 work items were completed this month. This included 641 routine jobs with the remainder being cyclic, emergency works or call outs and ordered works or programmed jobs.

Routine Works Completed

The routine works completed included the following:

- Grading was completed on 35 out of 343, or 10%, of unsealed roads
- Routine metalling was completed on 9 out of 343, or 2.6% of unsealed roads
- Potholing was completed on 54 roads, with 146 jobs completed
- Roadside mowing was completed on 6 roads
- Emergency works were completed for 13 jobs, for falling trees, and roads blocked due to over slips and under slips.

Aggregate Usage

The following aggregate was used during January, the equivalent of 14 truck loads of metal:

- GAP 30 100 m3
- GAP 40 0 m3

Cyclic Works Completed

• Remarking of road centerlines and edges lines is in progress.

Drainage Maintenance and Renewals

- 226 cesspit grates were cleared
- 71 culvert markers were replaced
- 17 culvert ends were cleared
- 1 culvert was replaced

Road Furniture Activities

- 0 signs posts were replaced
- 15 posts were painted
- 6 signs were replaced
- 2 signs were straightened
- 3 signs were cleaned
- 2 bridge edge markers was cleaned and 2 were replaced
- 58 edge markers were replaced and 1 was straightened

Structures Maintenance

• 4 bridge deck/drain holes were cleared
