

Te Tahua Toka Tū Moana - Mayoral Relief Fund Te Puka Tono Application Form

Te Kaunihera o Te Hiku o te Ika (the Far North District Council) has established a Mayoral Relief Fund to support homeowners and residents in the Bay of Islands–Whangaroa Ward who were impacted by the heavy rain event on 21 – 22 January 2026.

Te Tahua Toka Tū Moana - Mayoral Relief Fund is open for applications. Priority will be given to:

- Help with everyday essentials, getting around, and replacing household items.
- Repairs or recovery costs for buildings damaged by flooding.
- Essential items that aren't covered by insurance or other support

To apply for reimbursement of expenses, the costs must be related to the 21–22 January 2026 heavy rain event and be for a property in the Bay of Islands–Whangaroa Ward.

Applications close 5pm Friday 6th March 2026.

To support the application, please provide copies of invoices/receipts and other supporting evidence such as photographs. The information provided is required to enable a decision to be made on your application.
