# 1. About our community groups

Vision Kerikeri, Carbon Neutral NZ Trust and Kapiro Conservation Trust are not-for-profit community groups. Our groups have numerous members with professional expertise covering many fields. Vision Kerikeri volunteers have contributed information to the Council and others for more than two decades, seeking improvements in urban and district planning and greater protection for the natural environments.

# 2. The Landing's policies on pets

The Landing has adopted the following policies -

• Cats and dogs are prohibited - they cannot be kept by residential owners

## Working farm dogs are allowed

The Landing supports a more uniform approach to kiwi protection and improvement in dog ownership along the Purerua Peninsula.<sup>1</sup>

## 3. Proposed new policies and rules in The Landing Precinct

We seek new policies and rules in the Landing Precinct chapter to add specific protection kiwi and indigenous biodiversity –

**New policy** <u>TLP-Px</u>: Require active management and control of pest plants and pest animals, including possums, goats, mustelids, feral cats, feral dogs, and roaming or uncontrolled dogs.

**New policy** <u>TLP-Px:</u> Protect indigenous habitats and species particularly kiwi by avoiding the temporary or permanent introduction of dogs, cats or mustelids. *Working dogs* are exempt.

**New rule** <u>TLP-Rx</u>: Introduction of dogs, cats or mustelids on a temporary or permanent basis by residents, visitors, contractors or others (excluding *working dogs*).

Activity status: Prohibited.

New rule TLP-Rx: Vegetation clearance

Activity status: Discretionary

Before starting any indigenous or non-indigenous vegetation clearance, the area shall be monitored for kiwi and other vulnerable indigenous species by a certified conservation dog.

New rule <u>TLP-Rx</u>: Catteries and dog boarding kennels.

Activity status: prohibited.

**Revised objective TLP-O1**: Subdivision, use and development of The Landing that integrates <u>limited low density</u> development <u>maximum 48 lots</u> with restoration, <del>and</del> protection <u>and</u> <u>enhancement</u> of natural character, <del>and</del>-landscape <u>and coastal</u> values, and <u>ecological values</u>.

## 4. Proposed interpretation of 'working dogs'

We propose a new definition in the 'Interpretation' chapter to explain the meaning of working dogs, along the following lines –

**Working dog** means a working farm dog, certified Disability Assist dog<sup>2</sup>, or Conservation Dog certified by DOC<sup>3</sup> for detecting kiwi or other species. Such dogs must be kept under control at all times.

#### 5. Mataka Station's policies on pets

- Cats & mustelids are prohibited
- Dogs are limited to two per owner which must be confined (by way of an escape proof enclosure) to the owner's exclusive use area, except when dogs are in the company of that owner (or other invitee) and then on a leash at all times.<sup>4</sup>
- Working farm dogs are allowed.

Mataka Station website<sup>5</sup> states that:

"The conservation estate at Mataka provides a high degree of diversity and a haven for kiwi – one of the most iconic New Zealand birds at risk of extinction. The kiwi population of Mataka is one of the most significant in New Zealand and Mataka is a significant part of the campaign to protect kiwi and regrow the kiwi population."

"The two main measures used at Mataka to protect kiwis are the control of dogs and the use of a long term consistent predator program. Dogs are generally not permitted and tightly controlled and the predator program makes extensive use of bait stations, traps and shooting to eradicate the predators which kill kiwi."

## 6. Proposed new policies and rules in Mataka Precinct chapter

We seek new policies and rules in Mataka Station Precinct chapter to add specific protection kiwi and indigenous biodiversity —

**Revised policy PRECX-P4**: Encourage and support Require active management of pest plants and pest animals, including possums, goats, and mustelids, feral cats, feral dogs, and roaming or uncontrolled dogs.

Revised policy PRECX-P5: Require landowners to manage pets to avoid risks to threatened Protect indigenous habitats and species particularly kiwi by avoiding the temporary or permanent introduction of dogs, cats or mustelids. Working dogs are exempt

**New policy** <u>PRECX-Px:</u> Existing dogs shall be contained in an escape-proof enclosure (so that dogs and wildlife cannot pass through), and kept under control at all times to prevent any risk to kiwi or other vulnerable indigenous species.

New rule <u>PRECX-Rx</u>: Introduction of cats, mustelids or new dogs on a temporary or permanent basis by residents, visitors, contractors or others (excluding *working dogs*). Activity status: Prohibited.

**New rule PRECX-Rx**: Vegetation clearance.

Activity status: Discretionary

Before starting any indigenous or non-indigenous vegetation clearance, the area shall be monitored for kiwi and other vulnerable indigenous species by a certified conservation dog.

**Revised policy PRECX-P3**: Limit development within the precinct <u>to a maximum of 30 lots</u> to protect natural character and the characteristics, qualities and values that make ONL outstanding.

## 7. Missing elements in Mataka Precinct chapter

The Precinct chapter refers to Areas 1, 2 & 3 in the Precinct plan, however the plan provided by s42 report does not show Areas 1, 2 & 3.

Draft rule PRECX-R8 in the precinct chapter refers to standard PRECX-S3. However, PRECX-S3 is absent from the draft chapter.

## 9. Proposed biodiversity overlay


As noted in the evidence of Kiwi Coast, Purerua Peninsula has special features that deserve particular protection. The density of kiwi is unrivalled anywhere in New Zealand, therefore this peninsula is considered <u>Nationally Significant</u>. In addition, species seen or heard over the project area include kukupa, Australasian bittern, spotless crake, fernbird, NZ pipit, red knot, whimbrel, kororā, grey-faced petrel, NZ dotterel, pied stilt, oystercatcher, gecko (Northland green, Pacific and Woodworthia), flax snail, moko skink.

We urge the hearing panel to recommend to Council that additional protection be extended to the Purerua Peninsula as a specific overlay to recognise this peninsula as a nationally significant area for kiwi and the wider indigenous biodiversity.

We note that the area of Purerua has a particularly large area of Coastal Environment mapped by Northland Regional Council – shown in Figure 1. (In fact, the entire Purerua Peninsula is 100% surrounded by Coastal Environment.)

An overlay could provide for the protection of important areas of kiwi habitat and indigenous biodiversity, including the large area of Coastal Environment, and avoid the introduction of predators in the area except where special circumstances exist (such as working farm dogs that are kept under control at all times).
