

# Consultation Document – Proposal to amend the Revenue and Financing Policy 2024

## Introduction

The Far North District Council (Council) is proposing to amend its Revenue and Financing Policy 2024 (**RFP**) to enable the lawful collection of development contribution that from 29 May 2026.

This consultation document has been prepared in accordance with section 82 of the Local Government Act 2002 (**LGA**) to inform the community about the proposed amendment and invite feedback before Council makes its final decision.

The proposed amendment is necessary to give effect to Council's decision on 7 October 2025 to adopt and implement the Utu Whakawhanake Development Contributions Policy 2025 (**UWDCP**), with commencement delayed until 29 May 2026.<sup>1</sup>

## What is Council proposing?

Council proposes to amend a paragraph on page 4 of the RFP (**Table 1**), to reinstate development contributions as a funding source for growth-related capital infrastructure. The amendment:

- changes one paragraph on page 4 of the RFP to reinstate development contributions as a funding source
- is legally required before Council can implement the UWDCP adopted on 7 October 2025
- ensure those creating demand for new or upgraded infrastructure due to their development contribute a fair share of the costs
- protects existing ratepayers from bearing the full cost of growth-related infrastructure
- aligns with legislative requirements, Council's strategic objectives, community outcomes, and funding principles.

## Benefits of the Amendment

- **Intergenerational Equity:** Ensures current ratepayers are not subsidising infrastructure for future residents
- **Financial Sustainability:** Provides an additional, targeted revenue stream for growth infrastructure
- **Rate Relief:** Will eventually reduce pressure on general rates by attributing growth costs to development
- **Infrastructure Delivery:** Enables Council to fund necessary infrastructure to support sustainable growth

- **Transparency:** Creates a clear, legislatively governed funding mechanism with defined calculation methodologies
- **Fairness:** Allocates infrastructure costs proportionately to those creating demand

### What decision does Council need to make?

Following consideration of submission received during this consultation, Council will decide whether to:

- Adopt the proposed amendment to the RFP, as presented; or
- Adopt the proposed amendment with modifications in response to submissions; or
- Not proceed with the proposed amendment.

### Council's Decision-making Process

## Context and Situation

### Background

The Far North District has experienced significant growth pressures, particularly in certain communities and areas. This growth creates demand for new infrastructure and increased capacity in existing infrastructure networks, including water supply, wastewater treatment, stormwater systems, roads, reserves, and community facilities.

Since 2015, Council has suspended the collection of development contributions, only enabling collection through development agreements. During this period, the cost of providing growth-related infrastructure has been funded primarily through general rates, meaning existing ratepayers have borne the majority of full cost for infrastructure required to service new development.

This proposal is the result of Council resolution made at the Council meeting held on 11 December 2025, where Council chose **Option 1** (see **Table 3** below). This option best achieves fairness, financial stability, and compliance with legislative requirements.

# Why is the amendment necessary?

## Legislative Requirement

The LGA requires that before Council can lawfully collect development contributions, the RFP must explicitly provide for development contributions as a funding source. Without this amendment, Council cannot legally implement the UWDC Policy adopted on 7 October 2025.

## Intergenerational Equity

The reinstatement of development contributions aligns with the fundamental principle that "each generation of ratepayers should pay for the services they receive" – one of Council's core funding principles set out in the RFP<sup>3</sup>.

Currently, existing ratepayers are subsidising infrastructure for new development. This creates an inequitable burden on current residents who are paying for infrastructure that will primarily benefit future residents and property owners.

## Financial Sustainability

The Far North District faces significant infrastructure funding challenges. Te Pae Tata Three Year Long Term Plan 2024-2027 identifies substantial capital investment requirements to maintain, upgrade, and expand infrastructure networks<sup>4</sup>.

Without the ability to implement the UWDCP, the full cost of growth-related infrastructure falls on the existing rating base, contributing to:

- Higher rates for existing ratepayers
- Increased borrowing levels
- Potential deferral of essential infrastructure projects
- Reduced capacity to address existing infrastructure deficits

## Consultation Procedure (Section 82 LGA)

Section 82 of the LGA provides Council with the discretion of determining the length of consultation. Council have determined that the consultation period for this proposal will be a period of 4 weeks from 19 January 2026 to 15 February 2026.

The Council encourages any person or organisation affected by or having an interest in this proposed amendment to the RFP to send their views to the Council by making a submission.
