If you are planning on trading at a Community event which is being held on Council owned land you must apply for an "Event Permit" or contact the event organiser to obtain permission to trade at that event.

If you intend on trading within a speed limit zone along a State Highway more than 50kph you do not need to complete this form and must apply for approval from Waka Kotahi at https://www.nzta.govt.nz/resources/roadside-vendors-in-the-state-highway-corridor/.

No person may occupy public space and engage in the sale of goods of any description unless having obtained approval from Council.

Mobile Shop Approval Operated for a short period of time in one location before moving

on (e.g. an ice cream truck, food truck)

## Application for Approval - Mobile Shop, Hawkers or Tour Operator Occupying Public Space — Terms and Conditions

This licence is valid only from the date it is issued until the specified expiry date. Council reserves the right to cancel the licence at its sole discretion by giving the holder 24 hours' notice.

All commercial activities in public places are subject to these Terms and Conditions

- 1. Where required and not exempt, the applicant must hold a current Food Act 2014 registration certificate that must be prominently displayed in or on some part of the mobile vehicle or carried on the person at all times when open and trading for business.
- 2. The vehicle or hawker while operating, must be located so that customers must approach, queue, and access the mobile vehicle or hawker away from the road. There must be adequate and safe roadside customer parking available at the site.
- 3. The mobile vehicle or hawking signage must be kept clear of live lanes at all times.
- 4. The applicant and/or day to day operator identified in this application shall comply with any instructions given by the Police or Authorised Council Officers in the interest of public safety.
- 5. The applicant and/or day to day operator identified in this application shall ensure that the area surrounding the approval location shall be kept clean and clear of any litter.
- 6. Council reserves the right to withdraw this approval should it become clear that the applicant or day to day manager has breached their licence conditions.
- 7. Hawkers and mobile shops must be at least 400 meters (nearest point to nearest point) from any business premises selling like goods and services.
- 8. Approval to trade on Council land is at the sole discretion of Council and may be refused
- 9. Any person operating or responsible for a mobile shop may only display one advertising sign, sign must meet the permitted sign requirements and shall leave at least 1.5 meters of unimpeded footpath. An advertising sign cannot be placed on top of a vehicle unless it is permanently fixed to that vehicle.
- 10. This approval permits this licence holder to trade within the 50km/hr speed limit zone only on a State Highway in the Far North, if you intend on trading on any State Highway outside of that speed zone you must apply for consent of the Waka Kotahi (NZTA).
- 11. Your application will be assessed by the relevant Council departments managing the site(s) referred to in this application. The Council may include additional approval conditions as appropriate.
- 12. All applications must comply with the requirements of the Road Use Bylaw 2022.
