

## APPENDIX 1A: SCHEDULE OF OUTSTANDING NATURAL FEATURES

(Reference: **Part 3 District Wide Provisions, Section 12.1 Landscapes and Natural Features and Resource Maps**)

The Council is required under the Act to protect outstanding natural features and landscapes from inappropriate subdivision, use and development. There are a wide variety of human activities that may threaten the natural character, or continued existence, of important natural features within the District. In order to retain the scientific, educational and amenity values of sites of outstanding natural and geological significance, the Council has identified such sites in this Schedule and on the **Resource Maps**.

The major source of information has been the *“Inventory (and maps) of Important Geological Sites and Landforms in the Northland Region”*, Geological Society of New Zealand unpublished report 95/2, edited by J Kenny and B Hayward (1995). This Inventory lists the best examples of the wide diversity of physical features and processes that together characterise New Zealand’s long and complex geological history, the formation of its landforms and evolution of its unique biota. It was compiled using the combined knowledge and advice of a large sector of the geological, geomorphological, speleological and soil science community of New Zealand.

The Schedule below gives each site’s name, a brief description, the site’s significance and rating, a grid reference and map number. The rating signifies the site’s importance and vulnerability. Sites are listed in the Schedule under three levels (A-C) of significance:

### A International

Site of international scientific importance

### B National

Site of national scientific, educational or aesthetic importance

### C Regional

Site of regional scientific, educational or aesthetic importance.

Each site has been given a vulnerability classification (1 - 4) depending on its perceived vulnerability to human activities:

- 1 highly vulnerable to complete destruction or major modification by humans;
- 2 moderately vulnerable to modification by humans;
- 3 unlikely to be damaged by humans;
- 4 could be improved by human activity.

Eighty (80) natural landforms have been identified in the Far North District and are listed in this Schedule for their scientific, educational or scenic values. Three (3) sites have been assessed to be of international importance: Motukokako (Piercy) Island scarn with babingtonite and ilvaite; Camp Bay mylonite; and Marble Bay Permian fusulines and corals. A further twenty nine (29) sites have been assessed to be of national importance.

Three (3) sites have been assessed as highly vulnerable to human damage or destruction: Hokianga sand dunes, Te Paki sand dunes and Runaruna mud volcano.

In addition, nineteen (19) sites are considered to be very fragile and should therefore receive maximum protection. These have been marked with a (^) in the Table below.

A number of sites listed are too small to show the exact extent of them on the **Resource Maps**. These sites, marked with a (\*) on the Table below, have been shown as a single “point” feature on the Maps rather than as a defined area.

For more detailed information on the outstanding natural features listed in the Schedule, readers are directed to the Inventory published by the Geological Society of New Zealand (referred to above). This Inventory does not form part of the Plan.

## APPENDIX 1C: SCHEDULE OF LAKES

The Council has a responsibility under the Act for subdivision, use and development of land, and for the control of activities on the surface of water. Council has in **Chapter 12.7** identified various waterbodies from which buildings and impermeable surfaces must be set back in order to ensure that subdivision, use and development of land does not adversely impact upon these waterbodies.

This schedule of lakes has been sourced from information held by Northland Regional Council and the Department of Conservation. It is intended to provide information to applicants as to the location of lakes within the District to which setbacks apply. It also indicates the name and type of waterbody where known.

## APPENDIX 1D: SCHEDULE OF NOTABLE TREES

(Reference: **Part 3 District Wide Provisions, Section 12.5 Heritage and Zone Maps**)

The Council has a responsibility under the Act to identify and protect the heritage resources of the District. Accordingly, the Council has compiled a Schedule of Notable Trees.

Trees listed in this Schedule (and shown on the **Zone Maps**) have been evaluated using the New Zealand Institute of Horticulture Tree Evaluation Method. This method enables an objective assessment of the particular values of the tree at its location. Factors considered include:

- size of the tree;
- the importance of its position;
- the presence of other trees;
- the rarity of the species;
- the setting and the tree's importance to that setting;
- life expectancy and health of the tree;
- form or shapeliness of the tree;
- any other special features associated with the tree that may increase its value as a notable tree.

Only those trees that scored over 1,000 points have been included in the Schedule. Just under a third of the trees are native to New Zealand, the remainder being introduced. Just over half the trees in the Schedule occur in urban areas, the rest occurring in rural settings.

## APPENDIX 1E: SCHEDULE OF HISTORIC SITES, BUILDINGS AND OBJECTS

The Council has a responsibility under the Act to identify and protect the heritage resources of the District. Accordingly the Council has compiled a list of sites, buildings, and objects in the District that have historic significance. These are contained in the following Schedule.

The main source of information for historic sites, buildings and objects listed in the Schedule has been the New Zealand Heritage List for the Far North District. In addition some sites have been “rolled over” from the transitional district plan and still others have been nominated by public submission. In addition sites 231 - 234 inclusive have been sourced from the “*Inventory of Important Geological Sites and Landforms in Northland*”. They have been included in this Schedule because they are “man-made” geological features rather than “natural”, and are of outstanding historic significance.

## APPENDIX 1F: SCHEDULE OF SITES OF CULTURAL SIGNIFICANCE TO MAORI

(Reference: **Part 3 District Wide Provisions, Section 12.5 Heritage and Resource Maps**)

The Council has a responsibility under the Act to recognise and provide for the relationship of Maori and their culture and traditions with their ancestral lands, water, sites, waahi tapu, and other taonga. The Council must also have regard to kaitiakitanga (the exercise of guardianship and the ethic of stewardship), and shall take into account the principles of Te Tiriti o Waitangi (Treaty of Waitangi).

The provisions in **Chapter 2** of this Plan provide an overview of the resource management issues of concern to tangata whenua. Provisions in **Section 12.5** deal more specifically with the heritage values of Sites of Cultural Significance to Maori and the need to protect those values. One method of protecting Sites of Cultural Significance is to prepare an inventory of such sites and to restrict activities within such sites. Where there is an application to modify any Site of Cultural Significance to Maori, the tangata whenua shall be considered an affected party.

The following schedule has been sourced in part from information in the Transitional District Plan. In addition, the Council has resourced a series of workshops. The result of these workshops has been the identification of specific sites, the identification of areas which contain unmarked sites, and the people and/or organisations to be contacted in response to any application for a resource consent. The information gathered at these workshops is held by Council and is available on request.

The sites were located on 1:50,000 topographic maps (MS260 series) by circles drawn around individual sites (where the centre point of the circle depicts the location of the site); or large circles/areas drawn around a number of unmarked or “silent” sites. The location of these sites or areas is by map reference, or in the case of information from the Transitional District Plan, by legal description. Revealing the location of the “silent” sites, including waahi tapu, is a sensitive issue.

At this point in time, this Schedule only lists those sites that:

- (a) are on Maori land or on Department of Conservation estate; and/or
- (b) were in the Transitional Plan; and/or
- (c) are on general title land and there has been consultation with the affected landowner.

Where the column headed “Name & Description” contains a reference to “silent file”, the Council has made an order pursuant to s42 of the Resource Management Act 1991 prohibiting or restricting the publication or communication of any information supplied to avoid serious offence to tikanga Maori or to avoid the disclosure of the location of waahi tapu.
